Supervisors of Attendance

RESOLUTION NO. 2024 - 40

WHEREAS, Education Code section 48245 requires that school district supervisors of attendance, for districts with an average daily attendance ("ADA") of 1,000 or more students, be "lawfully certificated for the work by the county board of education"; and

WHEREAS, to be certificated pursuant to Education Code section 48245, the Fresno County Board of Education ("County Board") requires that each district supervisor of attendance of a district with an ADA of 1,000 or more students complete a training regarding the duties and responsibilities of a school district supervisor of attendance as set forth in Education Code Section 48240; and

WHEREAS, the County Board requires that district supervisors of attendance complete such training offered by the designated staff of the Fresno County Superintendent of Schools ("County Superintendent"), or complete a similar training approved by the designated staff of the County Superintendent; and

WHEREAS, as needed, designated County Superintendent staff provides training to school district supervisors of attendance regarding their duties and responsibilities; and

WHEREAS, as needed, the County Board will certificate individuals as district supervisors of attendance after their completion of the required training as set forth herein; and


WHEREAS, for the 2023-2024 school year, each of the districts listed on the attached Exhibit A had enrollment of 1,000 or more students; and

WHEREAS, each of the individuals listed on the attached Exhibit A have competed the required training requirements set forth herein by either attending a supervisor of attendance training provided by designated County Superintendent staff, or has provided proof of completion of a similar training to the designated County Superintendent staff.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education hereby certifies each of the individuals listed on the attached Exhibit A as district supervisors of attendance for the corresponding districts listed on the attached Exhibit A.
