WHEREAS, many state and national professional education associations hold celebrations during the week of April 10-16, 2021 focused on honoring our young children and those that serve as their Early Care and Education teachers or providers and to enhance public support; and

WHEREAS, the future of our community depends on the quality of the early childhood experiences provided to young children today through well-planned instruction and activities children will develop the skills, confidence, and self-esteem to succeed; and

WHEREAS, by calling attention to the need for high-quality early childhood services for all children and families within our community, these groups hope to improve the quality and availability of such services; and

WHEREAS, the Census Bureau reports that approximately fifty percent of working families rely on child care providers to help them care for their children while they work; twenty-five percent rely on relatives for child care; and nearly twenty-five percent arrange work schedules so that no child care is needed, substantiating the importance for high-quality early education.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools hereby joins the National Association for the Education of Young Children in proclaiming and observing April 10-16, 2021 as Week of the Young Child and encourages all educational communities to celebrate and honor those who dedicate themselves to serving children.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools hereby joins the National Association for the Education of Young Children in proclaiming and observing April 10-16, 2021 as Week of the Young Child and encourage all Fresno County School Districts to participate with appropriate activities and curriculum on this day and throughout the year.




