WHEREAS, the National Women’s History Project led to an annual observance of Women’s History Month, which highlights the contributions of women to events in history and contemporary society and is celebrated during March in the United States; and

WHEREAS, the commemoration began in 1978 as “Women’s History Day” and was later recognized as a national week in 1980 before recognized as a month in 1987; and

WHEREAS, Women of every race, class and ethnic background have made significant contributions to the growth and strengths of our society in countless recorded and unrecorded ways; and

WHEREAS, Women of every race, class and ethnic background served as early leaders in the forefront of every major social change movement; and

WHEREAS, the Fresno County Superintendent of Schools has encouraged pathways for girls to pursue Science, Technology, Engineering, Arts and Mathematics (STEM) careers and under-representation of women in nontraditional careers by supporting teachers and students through professional learning and STEM for Girls Conference.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools do hereby recognize the month of March 2024 as Women’s History Month and encourage all Fresno County School Districts to participate with appropriate activities and curriculum on this day and throughout the year.


