WHEREAS, the Fresno County Board of Education (County Board) appreciates the services provided by members of the County Board and provides compensation for meeting attendance in accordance with Education Code 1090 and Board Bylaws No. 9250.

WHEREAS, Education Code section 1090 provides that the monthly compensation provided to a County Board member shall be commensurate with the percentage of meetings that the member actually attended during the month, unless the County Board, by resolution duly adopted and included within its minutes, finds that at the time of the meeting the member was performing services outside the meeting on behalf of the County Board, the member was ill or on jury duty, or the absence was due to a hardship deemed acceptable by the County Board.

WHEREAS, the County Board finds that Board Member Bryan Burton did not attend the County Board meeting on March 17, 2022 for the following reason(s) (check each applicable):

- The member was performing services outside the meeting on behalf of the County Board at the time of the meeting.
