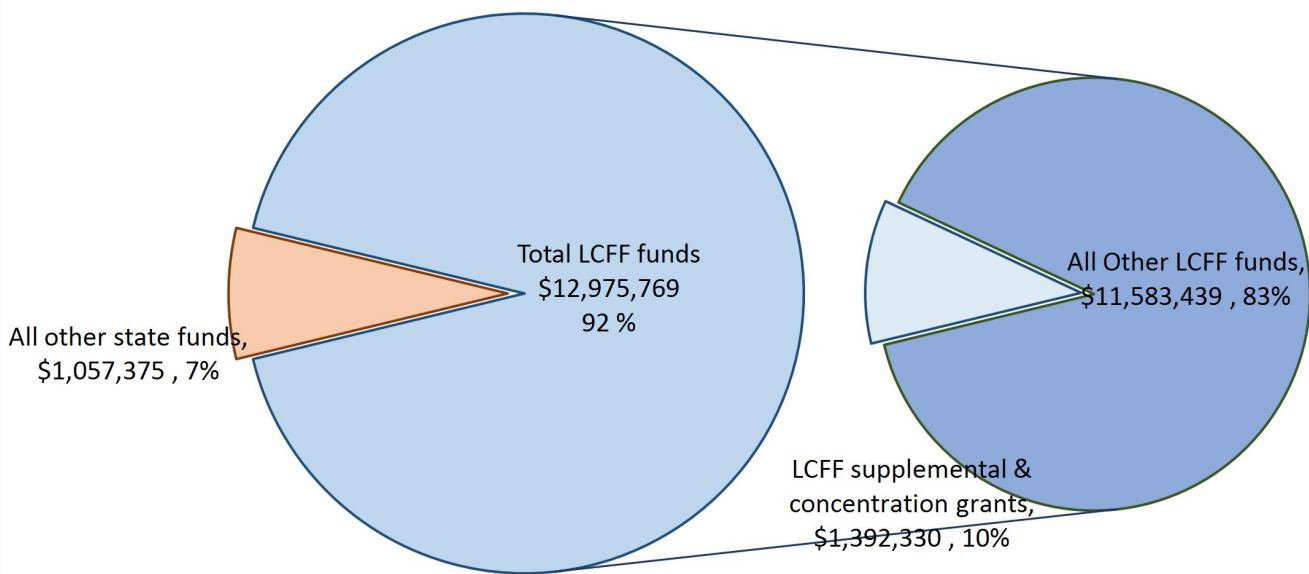

Projected Revenue by Fund Source

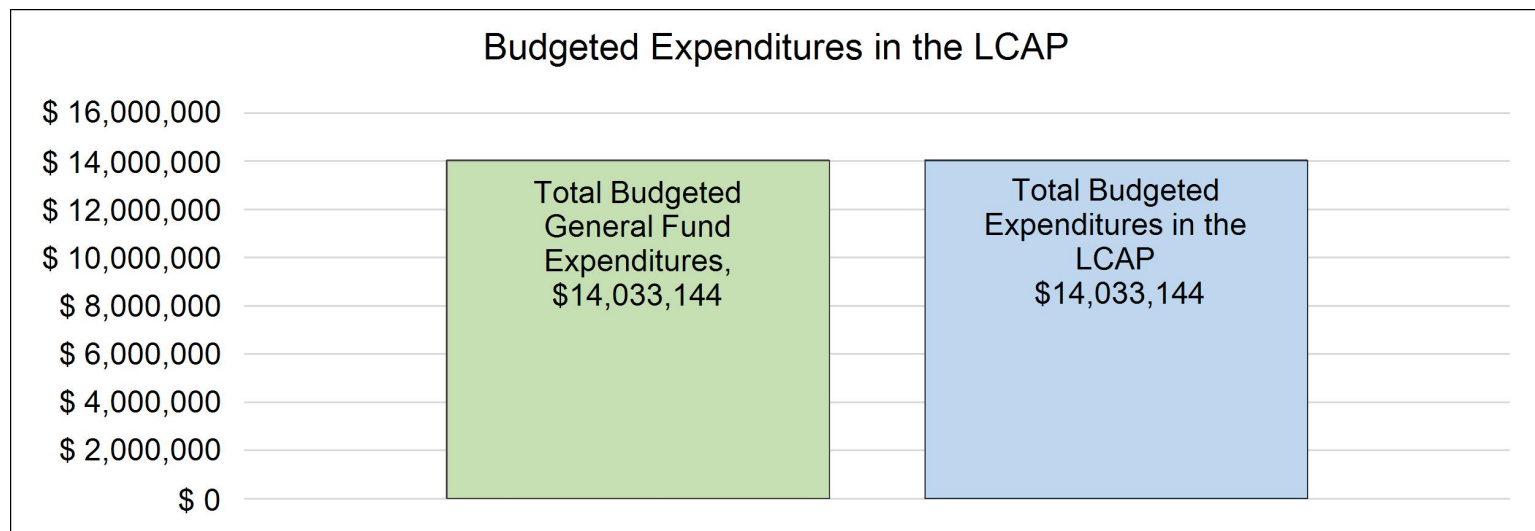


This chart shows the total general purpose revenue Clovis Unified School District - Clovis Online Charter School expects to receive in the coming year from all sources.

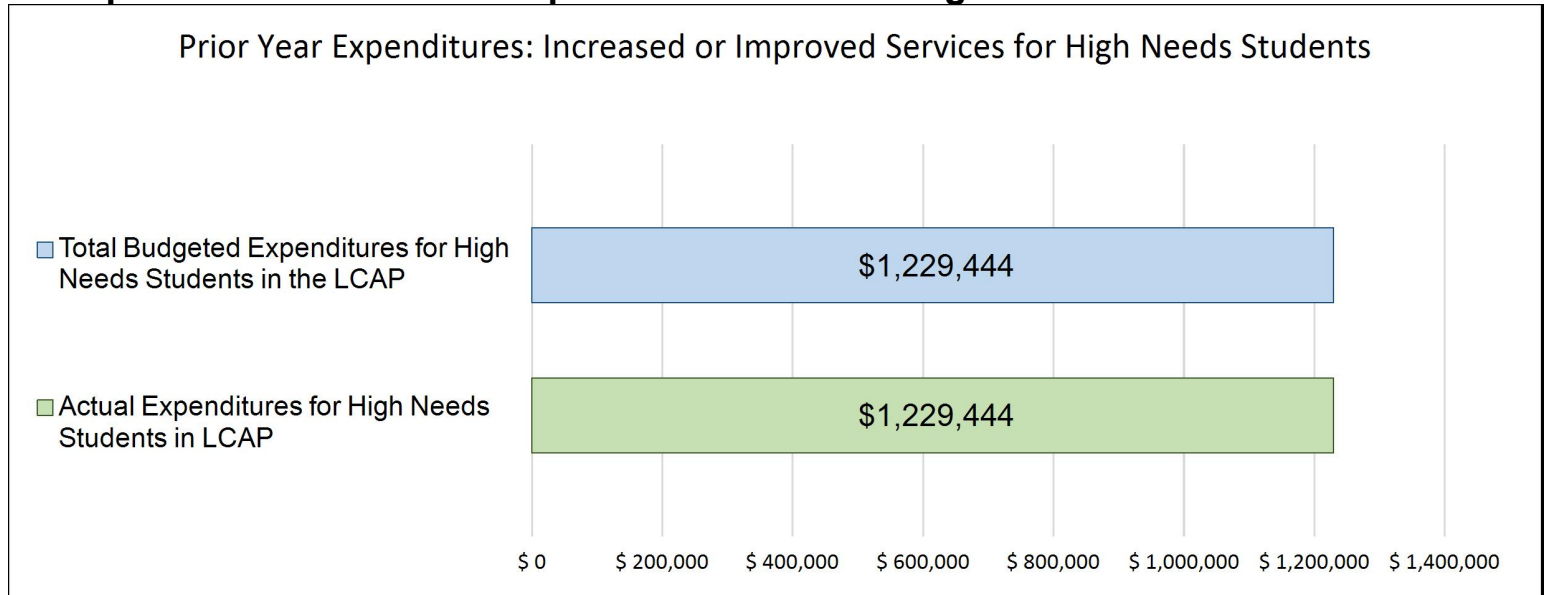

Plan Summary [2026-27]

General Information

Clovis Online Charter began serving students at the start of the 2009–10 school year, initially enrolling only a small group of students. Today, the school serves nearly 1,000 students across nine counties. A significant portion of our student body resides within Clovis Unified School District boundaries, while the remainder comes from surrounding areas. Approximately 83% of our students live in Fresno County, with the rest coming from eight neighboring counties.

Our student demographics include 51% Hispanic, 31% White, 9% Asian, 3% African American, and 6% identifying as other. Nearly 56% of our students are socioeconomically disadvantaged, and around 3% are identified as students with special needs, English Learners, or foster youth.

Clovis Online Charter (COS) is committed to setting the standard for excellence in online education. Guided by our mission, we aim to create a high-quality educational environment that supports the academic, physical, and social development of every student, encouraging them to reach their full potential.

Our mission states:

"Clovis Online is committed to providing students a nontraditional, distance learning program that is designed to meet the individual needs and learning abilities of students who may not have been successful at traditional comprehensive schools, or who have been successful but now require an alternative approach to learning. We believe all students can learn, and we must explore different strategies to ensure every student can graduate and thrive—mind, body, and spirit."

At Clovis Online Charter and throughout Clovis Unified, we believe that every student can learn, and we are dedicated to meeting the educational needs of all children.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Clovis Online Charter School continues to demonstrate strong performance on the California School Dashboard, with no indicators in the red performance level. Our 89.5% graduation rate reflects the strength of our targeted, standards-based academic program. This success is driven by personalized learning plans, consistent student-teacher interaction, a dedicated instructional staff, a rigorous curriculum, and comprehensive support services that address students' academic, social, emotional, and mental health needs.

While academic performance compared to our charter district highlights areas for continued growth, our Advanced Placement (AP) program maintains a 67% pass rate, reinforcing our commitment to academic rigor and college readiness. Continued enrollment growth has allowed us to further individualize instruction, aligning with our district's vision of developing excellence in mind, body, and spirit.

Areas for Improvement

Despite these successes, we have identified two key areas for growth:

College and Career Indicator (CCI):

Currently, 29.9% of students are classified as "Prepared," with an additional 25% as "Approaching Prepared." Because many students enroll with credit deficiencies, it remains critical to prioritize college and career readiness alongside on-time graduation. We are strengthening our focus on A-G completion, expanding dual enrollment opportunities, and continuing to build Career Technical Education (CTE) pathways in collaboration with Clovis Unified's alternative education programs.

CAASPP Achievement:

Our most recent CAASPP results demonstrate continued growth in student achievement and reflect the impact of our targeted instructional supports. In English Language Arts, 50.35% of students met or exceeded standards, while 40.98% met or exceeded standards in Mathematics. These outcomes show improvement over prior years and signal positive momentum in addressing learning gaps.

This progress is particularly meaningful given that many of our students enter with significant academic gaps and credit deficiencies. Through intentional WIN intervention, standards-based instruction, and increased student-teacher engagement, we are seeing measurable gains in overall student performance. Moving forward, we will continue to strengthen core instruction and expand targeted supports to increase proficiency levels across all student groups.

By addressing these challenges with focus and urgency, Clovis Online Charter School remains committed to continuous improvement and ensuring all students are prepared for success in college, career, and life.

During the comprehensive needs assessment, the team analyzed the 2024 California School Dashboard, zeroing in on student groups rated red or orange in ELA, Math, and College and Career readiness to surface the most urgent equity gaps. The findings were then triangulated with local benchmark scores, attendance logs, and educational feedback to uncover root causes and shape targeted, evidence-based actions to boost academic outcomes and improve College and Career Readiness for the flagged groups to ensure the best use of the LREBG funds.

Action 1.4 Academic Counselors

Metrics: College and Career Readiness

Funds were used to support academic counselors in the distribution and implementation of a range of services and resources designed to remove barriers to learning and improve student outcomes. This included evaluating current and past academic struggles, reviewing transcripts, developing individualized academic success plans, and connecting students to appropriate mental health supports. These services were complemented by instructional assistants, supplemental curriculum, additional assistance from teachers or support providers, credit recovery opportunities, expanded academic and career counseling, and enhanced college and career readiness initiatives.

These tools were incorporated into online curriculum platforms and reinforced through push-in support from teachers and instructional assistants. This comprehensive approach helped accelerate learning for all students, with particular impact for English Learners, LTELs, Foster Youth, and students experiencing homelessness by fostering consistent relationships, culturally responsive teaching, and access to materials.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The collaborative involvement of our educational partners has been instrumental in shaping the 2026 Local Control and Accountability Plan (LCAP). Feedback gathered from staff, parents, and students revealed consistent themes and meaningful insights that directly informed our goals, actions, and priorities for the coming year.

Staff Perspective: Fostering an Inclusive, Safe, and Supportive Environment

Staff emphasized the importance of maintaining an inclusive school environment, accepting, and physically safe. Feedback reflected a strong appreciation for the school's diverse student population and the intentional efforts to build a culture rooted in respect and belonging. At the same time, staff identified a continued need to strengthen supports for student mental health and emotional well-being.

To address these needs, staff recommended expanding peer support and mentorship opportunities to promote connection and shared responsibility among students. They also highlighted the importance of increasing access to counseling services and ensuring timely referrals for students in need. Additionally, staff suggested integrating mindfulness and wellness practices into the daily routine, along with providing ongoing professional development in trauma-informed practices and mental health awareness.

Parent Perspective: Enhancing Learning Through Innovation and Support

Parents expressed strong support for the school's current curriculum and instructional approach, particularly its flexibility and individualized learning model. They value the ability to meet students where they are while maintaining high expectations for achievement. However, parents also identified opportunities to further strengthen academic outcomes and student engagement.

Key recommendations included expanding tutoring and enrichment opportunities, especially in reading and mathematics, and increasing access to project-based and experiential learning. Parents also emphasized the importance of clear and consistent communication regarding student progress and academic expectations. Continued innovation within the curriculum was encouraged to ensure it remains responsive to the diverse and evolving needs of all learners.

Student Perspective: Addressing Academic Needs and Increasing Motivation

Student feedback highlighted a strong need for additional academic support, particularly in reading, writing, and mathematics. Students also expressed a desire for increased motivation and more engaging learning experiences.

Students recommended targeted academic interventions, including small-group instruction and one-on-one support. They also expressed interest in academic clubs and peer-led study groups to foster collaboration and accountability. To increase engagement, students suggested incorporating more interactive and gamified learning experiences, along with providing meaningful opportunities for student voice and leadership in shaping their educational experience.

Key Themes Across Stakeholder Groups

Analysis of feedback across all educational partners revealed three consistent priority areas:

Social-Emotional and Mental Health Support

There is a shared recognition of the importance of prioritizing student mental health and emotional well-being. Stakeholders consistently emphasized that strong social-emotional support systems are essential to both academic success and overall student development.

Academic Intervention and Personalized Support

Stakeholders underscored the need for timely and targeted academic interventions, particularly in literacy and mathematics. Strengthening systems of support while maintaining high expectations and adapting to diverse learning styles remains a key priority.

Behavioral Support and School Climate

Concerns related to student behavior and suspension rates highlighted the need for enhanced behavioral support structures. Stakeholders advocated for proactive approaches, including clear expectations, restorative practices, and strategies that promote positive school climate.

Families of English Learners (EL), Foster Youth (FY), and Low-Income (LI) students expressed strong support for the district's current engagement and intervention efforts. While affirming the overall direction of services and metrics, they encouraged continued investment in strategies that further elevate student achievement and promote long-term success for historically underserved student groups.

Clovis Online has developed this broad goal because not all our students are currently performing at or above grade level. Our FY, EL, and LI students are performing below all students as measured by the California Dashboard, local assessments, and data on DataQuest. This goal was developed to reflect our school's commitment to a quality education and to accelerate learning, ensuring that all students are met with challenging curriculum and appropriate instruction. Using research-based principles, we seek to look for innovative methods, better-trained personnel, and quality programs to offer our students the time and means necessary to achieve their highest potential. We have carefully selected metrics to track progress across a wide span of areas. We measure overall achievement in mathematics and English Language Arts (ELA) using state and local assessment data. We monitor the progress and reclassification of English learners. We believe it is important that students are prepared for college and career, monitoring things like A-G completion, AP course enrollment, etc. Clovis Online carefully monitors student progress to ensure that students stay actively enrolled and participating by monitoring dropout rates.

Clovis Online School has effectively implemented a comprehensive set of actions aligned with our goal of expanding academic support and ensuring equitable access to technology. These efforts have contributed to increased student engagement, improved academic outcomes, and measurable progress toward graduation for all student groups, including students with IEPs, English Learners, Foster Youth, and Low-Income students.

Achieved Outcomes

Technology Access and Infrastructure:

Clovis Online fully upgraded its technology infrastructure, ensuring that all students and staff have consistent and reliable access to devices, internet connectivity, and digital learning platforms. This access supports personalized learning and aligns with district priorities for instructional technology.

Credit Recovery and Graduation Support:

To support students at risk of falling behind, the school implemented a targeted summer intervention program. Teachers, counselors, and administrators collaborated to provide focused credit recovery opportunities, resulting in increased progress toward graduation for participating students.

Instructional and Curriculum Support:

Several initiatives were implemented to strengthen instruction and support student learning across content areas, including:

- Distribution of supplemental instructional materials to address diverse learning needs

- Use of online curriculum platforms supported by push-in teachers and instructional assistants

- Employment of bilingual instructional assistants to support English Learners and promote equitable access

Professional Development:

Ongoing, targeted professional development was provided to teachers and staff to strengthen instructional practices, effectively utilize online tools, and implement differentiated strategies to meet the needs of all learners.

Student and Family Engagement:

Clovis Online expanded efforts to engage families through literacy-focused programs and consistent communication. Administrative support was designated to coordinate outreach and strengthen connections between school and home.

Social-Emotional and Behavioral Support:

Recognizing the importance of student well-being, the school enhanced its social-emotional supports to ensure students have access to mental health resources and timely interventions when needed.

There were no material differences between the budgeted and estimated actual expenditures for this action. The goal of enhancing equitable access to instructional and operational technology was fully funded and implemented as planned. Allocated resources supported infrastructure upgrades, device distribution, and expanded digital access, ensuring all students and staff had the necessary tools to support teaching and learning.

The Planned Percentage of Improved Services was consistent with the Estimated Actual Percentage of Improved Services. Targeted student groups including English Learners, Foster Youth, and Low Income students benefited from increased access to technology. These efforts supported improved academic outcomes and reinforced the District's commitment to equity and access.

These actions contributed to progress toward this goal by reducing barriers to learning, expanding access to academic and support services, and creating conditions that support both academic success and student well being. Implementation of these strategies has strengthened Clovis Online School's ability to continue improving student achievement and advancing equity.

Staff reported stronger instructional delivery, and students, particularly those in targeted groups, experienced more personalized and accessible learning opportunities. These outcomes indicate that the technology access initiative has supported the District's goals related to equity, academic achievement, and instructional innovation.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

After reviewing prior practices and evaluating this year's outcomes, Clovis Online School has identified opportunities to strengthen its approach to equitable access to instructional and operational technology. While the goal was largely met, with improved access and stronger digital learning experiences, stakeholder feedback identified the need for continued refinement.

Moving forward, the focus will remain on equitable access with increased attention to maintaining and upgrading technology infrastructure to meet the evolving needs of students and staff. In addition to tracking device access, the school will implement measures to monitor technology usage and student engagement, providing a clearer picture of how digital tools are supporting daily instruction.

Target outcomes will include increased engagement and improved performance among historically underserved student groups, including English Learners, Foster Youth, and Low Income students. Emphasis will also be placed on strengthening digital literacy and achievement in technology supported learning environments.

To support these outcomes, the school will expand professional development focused on effective technology integration and increase access to technical support for students and families to ensure consistent use and timely problem solving. These adjustments are intended to build on current successes while addressing areas for continued growth.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The implementation of actions remained closely aligned with the initiatives outlined in the LCAP, with only minor adjustments made to respond to changing student and operational needs. Clovis Online School maintained core programs and services through consistent funding

of operational areas, including maintenance, instructional supplies, utilities, transportation, custodial services, BTSA, staffing, administration, clerical support, salaries, benefits, and intervention supports. Custodial and maintenance staff ensured that learning environments remained clean, safe, and supportive of student learning, with ongoing attention to facility upkeep and repairs.

To support instructional priorities, the school provided updated, standards aligned materials to implement Common Core and State Standards across a rigorous curriculum. Participation in district Parent Resource Centers, particularly within the alternative education network, supported stronger family and school connections. Clovis Online also expanded family engagement through workshops, training opportunities, and resources designed to help families better navigate school systems. These efforts were coordinated through the Transition Counselor and the administrative team.

To meet the needs of targeted student groups, the school provided supplemental instructional materials along with oral and written translation services to ensure equitable access to instruction and communication. A continued focus was placed on sustaining intervention services and academic supports. There were no significant differences between planned and actual implementation. Minor logistical challenges, including coordination of translation services and timely delivery of materials, were addressed without impacting overall program delivery. Collectively, these efforts supported a stable, safe, and academically focused learning environment aligned with the school's goals.

All planned actions and services were fully funded and implemented as intended, ensuring consistent support for student learning, equity, and engagement. This alignment reflects accurate budget forecasting and a strong commitment to maintaining and delivering the services outlined in the LCAP.

The actions implemented to date have been effective in advancing progress toward the established goal. Investments in technology access, academic intervention, instructional support, and family engagement have increased student participation, expanded access to rigorous coursework, and supported more equitable learning opportunities across all student groups.

The use of supplemental instructional materials, ongoing professional development, and targeted supports for English Learners, Foster Youth, and Low Income students has strengthened both academic support and student engagement. Family engagement efforts, including expanded access to translation services, have improved communication between the school and home.

While continued attention is needed to address achievement gaps and strengthen outcomes in key content areas, these actions have established a strong foundation for ongoing improvement and sustained progress.

The implementation of this objective was effective and closely aligned with the original plan. Efforts to recruit, develop, and retain a diverse, high-quality staff were intentionally carried out through strategic hiring practices, consistent support systems, and targeted professional development. All classrooms were staffed with appropriately credentialed teachers, ensuring compliance with assignment requirements and maintaining instructional consistency across the school. Professional development opportunities were provided throughout the year, with full staff participation, emphasizing curriculum alignment, effective instructional practices, and strategies to support students' social-emotional and cultural needs.

There were no significant deviations between planned actions and actual implementation. Overall, implementation resulted in stronger instructional practices, increased student engagement, and enhanced collaboration among staff. A continued focus on a holistic approach, balancing academic rigor with student well-being, remained central throughout the process, reinforcing the district's commitment to meeting the diverse needs of all students.

Expenditures remained closely aligned with projections, and the targeted percentage of improved services for unduplicated students was fully realized. This consistency reflects strong implementation, careful monitoring, and effective stewardship of resources throughout the year.

The actions implemented to date have been effective in advancing the goal of recruiting, developing, and retaining a diverse and highly qualified staff. Ensuring that all classrooms are staffed by appropriately credentialed teachers, combined with comprehensive professional development, has strengthened instructional quality and enhanced the overall student experience. Professional learning was completed by all teachers and focused on curriculum alignment, effective instructional practices, and strategies to support students' social-emotional needs, contributing to a more inclusive and supportive learning environment.

Ongoing professional development has also supported increased collaboration among staff and higher levels of student engagement. The emphasis on culturally responsive teaching, along with continued attention to social-emotional learning, has helped create a more inclusive and enriching classroom setting for all students.

While implementation has been successful overall, some challenges arose in tailoring professional development to meet the varied needs and experience levels of staff. Moving forward, refinements will be made to professional development to better address the varying needs and experience levels of staff. This includes expanding personalized and differentiated learning opportunities, allowing teachers to engage in training aligned to their individual areas for growth.

While all teachers participated in professional development, the need for more sustained support, particularly for newer staff, was identified. In response, the coaching and mentoring model will be strengthened to provide ongoing guidance throughout the year, with an increased emphasis on culturally responsive teaching and supporting students' social-emotional well-being.

Metrics will remain largely consistent, with continued monitoring of professional development participation, teacher feedback, and the impact on student engagement and outcomes. Target outcomes will continue to focus on strengthening instructional quality, increasing collaboration

among staff, and effectively meeting the diverse needs of students, with a continued emphasis on fostering an inclusive and culturally responsive learning environment.

 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.
