EMPLOYEE OF THE MONTH

This month the Fresno County Office of Education and the Fresno County Board of Education are honoring **Mike Orlando and Karen von Felten** as their September 2002 Employees of the Month.

It would, quite simply, be impossible to nominate these two outstanding employees separate from one another. They are a TEAM in the truest sense of the word. For over 25 years, Mike and Karen have dedicated countless hours both in the classroom and beyond, and have positively impacted the lives of students, families and staff members throughout Fresno County. Like Frick and Frack, John and Yoko, Rogers and Hammerstein, Batman and Robin, or any other historical twosome, Mike and Karen have made a difference. They have brought expertise and quality instruction to FCOE-operated programs for students with severe disabilities. Mike was one of the first teachers to pilot the Personal and Social Education Program. He has supervised the vocational training and Summer Youth Employment Programs for our students, and has also coordinated their participation in Workability. He also monitors our mobility-training program, which has made it possible for our students to utilize public transportation. He has worked closely with community agencies in order to facilitate the successful transition of our students to post-school options. He has also devoted many hours as a Special Olympics volunteer, and has served as the Event Director for the local power lifting, soccer, and basketball meets.

Karen has been a mentor teacher and was the author of the FCOE Community-based Handbook. She was one of the very first teachers to participate in the PEERS Program and first to implement the Individual Critical Skills Model. Her expertise in curriculum, scheduling, and instruction for students with moderate/severe disabilities has proved to be invaluable, and her ideas and techniques always become "best practices." After working together at Cook-Bullard and Cook-Hamilton schools from 1980 to 1984, Karen and Mike were the first Adult Transition Program staff to "team-teach" in a totally integrated

environment. They created an outstanding program on the California State University, Fresno campus, and forged relationships with numerous departments that have continued to this day. Three years ago, Karen and Mike took another big step when they assumed full-time responsibility for support to ATP and other FCOE Special Education Programs.

As always, they are the same miraculous team, ever in sync, and still doing what they love most—making great things happen for our students, their families and their friends. No duo are more deserving, or overdue, for this recognition than Mike Orlando and Karen Von Felten.
