The Migrant Health Program provides 18 on-site school clinics throughout the school year. In this setting, Melinda, as a nurse practitioner with a medicine furnishing number, performs head-to-toe CHDP examinations and is in charge of dispensing parasitic medication. Melinda is bilingual, and an effective communicator with staff, students, and parents. Melinda is a valued health team member.
