- State Budget: K-12 has prepared for budget cuts. Deputy Superintendent of Business services reported on COLAs: COLA will be given to all categoricals. 2.4% COLA will be given to all programs. Money will not be spent until the budget is signed.
- Categorical Reforms: Deedee Albert's Bill is endorsed by Republicans and Democratics. The Bill protects categoricals in six major categories but gives greater flexibility. The Governor's Proposal is still on the table folding into the revenue limits.
- The Board Aviation Project:

Don Collins updated the Board on the development of the Aviation Project. He also reviewed the new media equipment needing to be purchased.

Janie Rocheford and Randy Reed from Library Media Services updated the Board on a recent visit to Lemoore Naval base. The purpose of the visit was to film vignettes for the Board project.
