Superintendent Mehas reported on the following items:

State Budget: Per the request of the Superintendent Mehas, Deputy Superintendent Pietro reported.

The COLA and the deficit are set at this time. The County Office has written a letter of support for legislation that will not allow the E-rate money to be spent differently than past practice. FCOE is still holding off on spending until all things are finalized.

- Senator Deedee Alpert's bill SB 1448 will help in the area of categorical funds.
- Superintendent Mehas has participated in the Juvenile Court Project. He requested that interested Board Members communicate support to the Board of Supervisors for the new Juevenile Court's construction.
- E-Rate: Superintendent Mehas has sent letters to U.S. Representatives George Radanovich and Cal Dooley following up on the federal investigation of E-rate funds.
- The reception for the Central California Leadership Institute was outstanding. Superintendent Mehas suggested that the Board acknowledge Dr. Welty for taking a leadership role on the issue. Another suggestion was to encourage the participation of the Fresno County School Trustees Executive Board.
- In response to the attention being given to the Superintendence of FUSD, Superintendent Mehas will write an opinion editorial in support of the process of election and removal of Superintendents.

COMMUNITY INPUT

CTA President Mike Lepore reported on the following:

- His current areas of focus are to keep insurance rates reasonable and to keep Fresno
 County teaching positions competitive and attractive in comparison to other counties.
- Interest in the cost of benefits has escalated amongst teachers.
