WHEREAS, Article XIII B of the Constitution of the State of California, as approved by the voters in November 1979, requires the establishment of appropriations limits on proceeds of tax revenues for public agencies, beginning with the 1980-81 fiscal year; and

WHEREAS, each public agency is required to determine and adopt the actual appropriations limit for the previous year 2024-25; and

WHEREAS, to determine and adopt the estimated appropriations limit for the current 2025-26 fiscal year; and

WHEREAS, the appropriations limits for the Office of the Fresno County Superintendent of Schools have been calculated in accordance with Article XIII B of the State Constitution and Division 9 of Title I of the Government Code

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools for the purposes of Article XIII B, hereby established this agency's appropriations limits of **\$46,734,861.39** for the 2024-2025 fiscal year and **\$44,044,333.83** for the 2025-2026 fiscal year.
