WHEREAS, studies and activities pertaining to the Reverend Dr. Martin Luther King, Jr.'s life will help students gain a better understanding of justice, integrity, freedom and love; and

WHEREAS, knowledge and understanding of the philosophy of nonviolence, respect for the rights of others, dignity and self-worth, empathy, civil rights, and quality of life will help students carry the message of the Reverend Dr. Martin Luther King, Jr. forward into the future to ensure living together in peace and harmony; and

WHEREAS, California Education Code 37220 (a) (2), designates the third Monday in January (January 19, 2026) as "Martin Luther King, Jr. Day" and requires that all public schools and educational institutions throughout the state, on the first school day before or after the holiday occurs, hold suitable exercises commemorating and directing attention to the history of civil rights movement in the United States, and particularly the role therein of the Reverend Dr. Martin Luther King, Jr.; and

WHEREAS, Fresno County Superintendent of Schools joins the countywide attempt to pay tribute to the 2026 celebration of the Reverend Dr. Martin Luther King, Jr.


