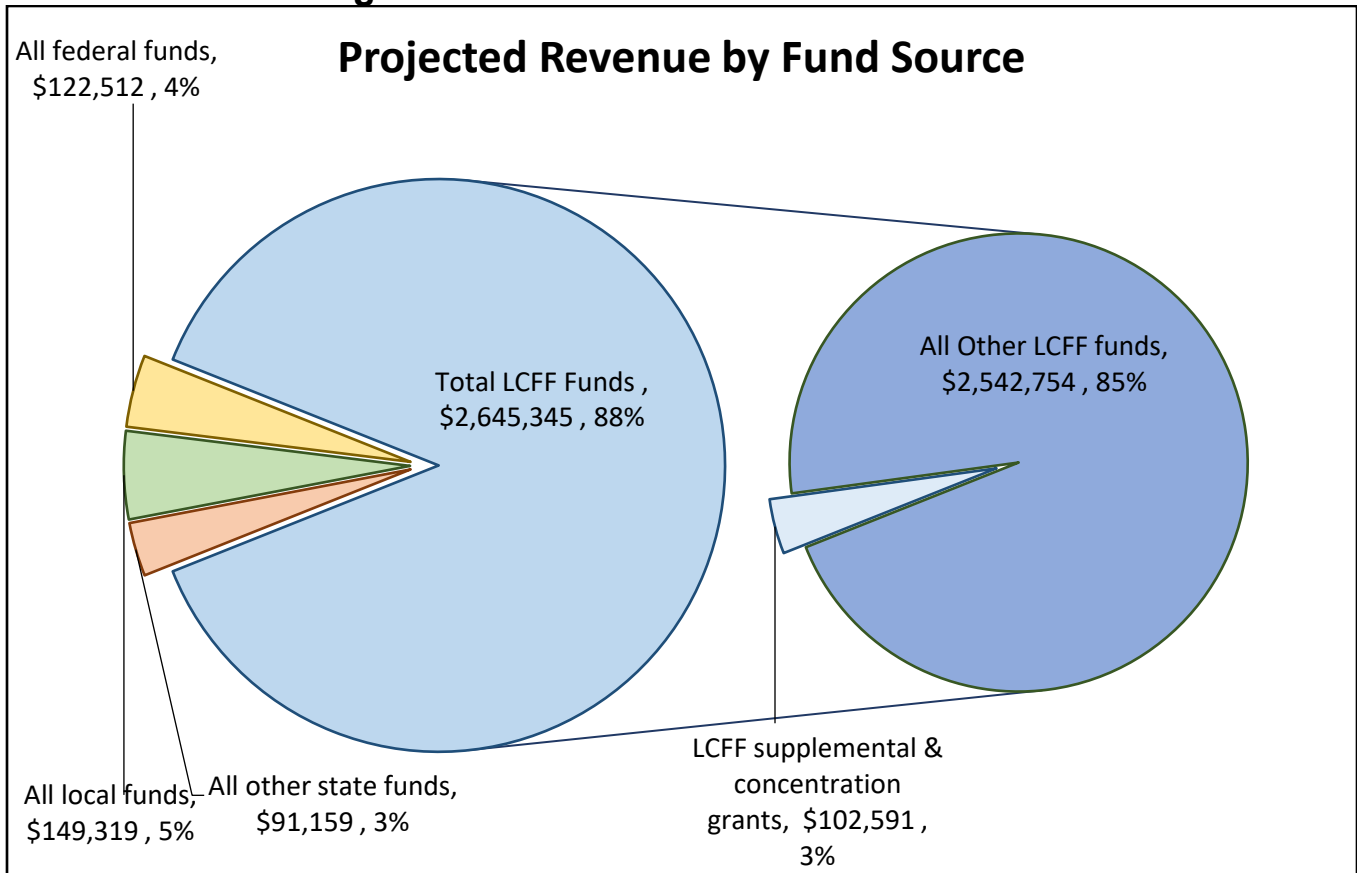

## Budget Overview for the 2024-25 School Year

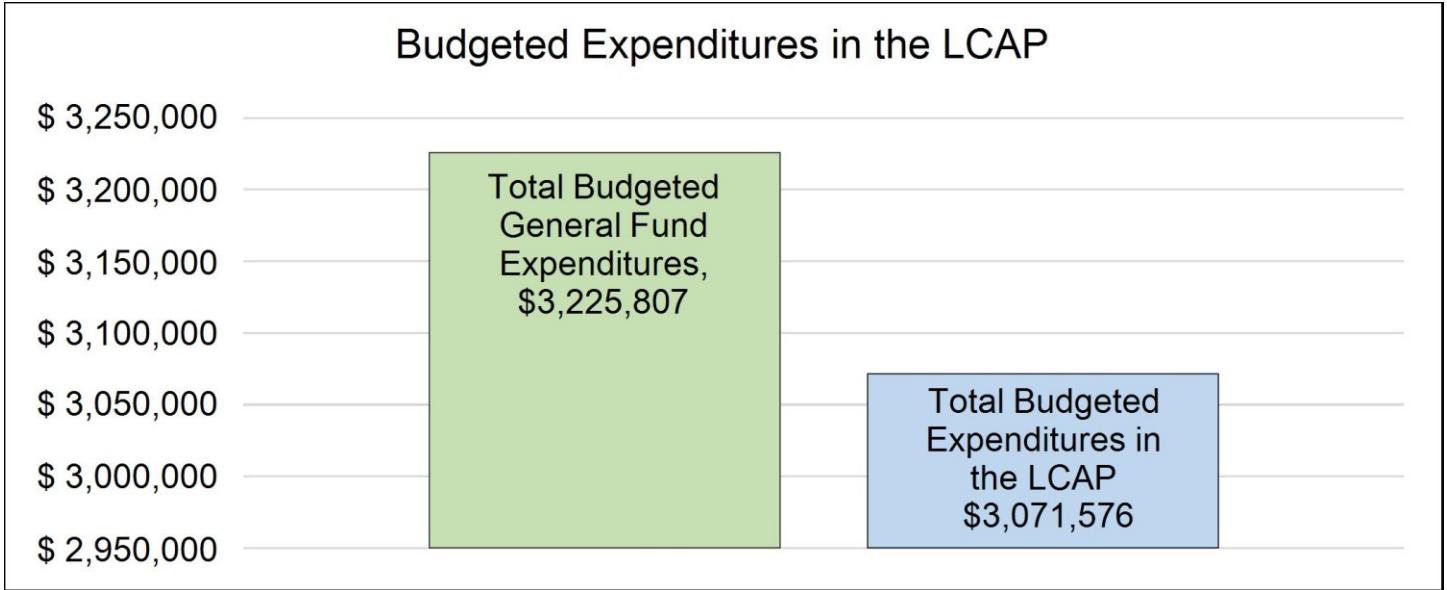


This chart shows the total general purpose revenue Clay Joint Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Clay Joint Elementary School District is \$3,008,335, of which \$2,645,345 is Local Control Funding Formula (LCFF), \$91,159 is other state funds, \$149,319 is local funds, and \$122,512 is federal funds. Of the \$2,645,345 in LCFF Funds, \$102,591 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The text description of the above chart is as follows: Clay Joint Elementary School District plans to spend \$3,225,807 for the 2024-25 school year. Of that amount, \$3,071,576 is tied to actions/services in the LCAP and \$154,231 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

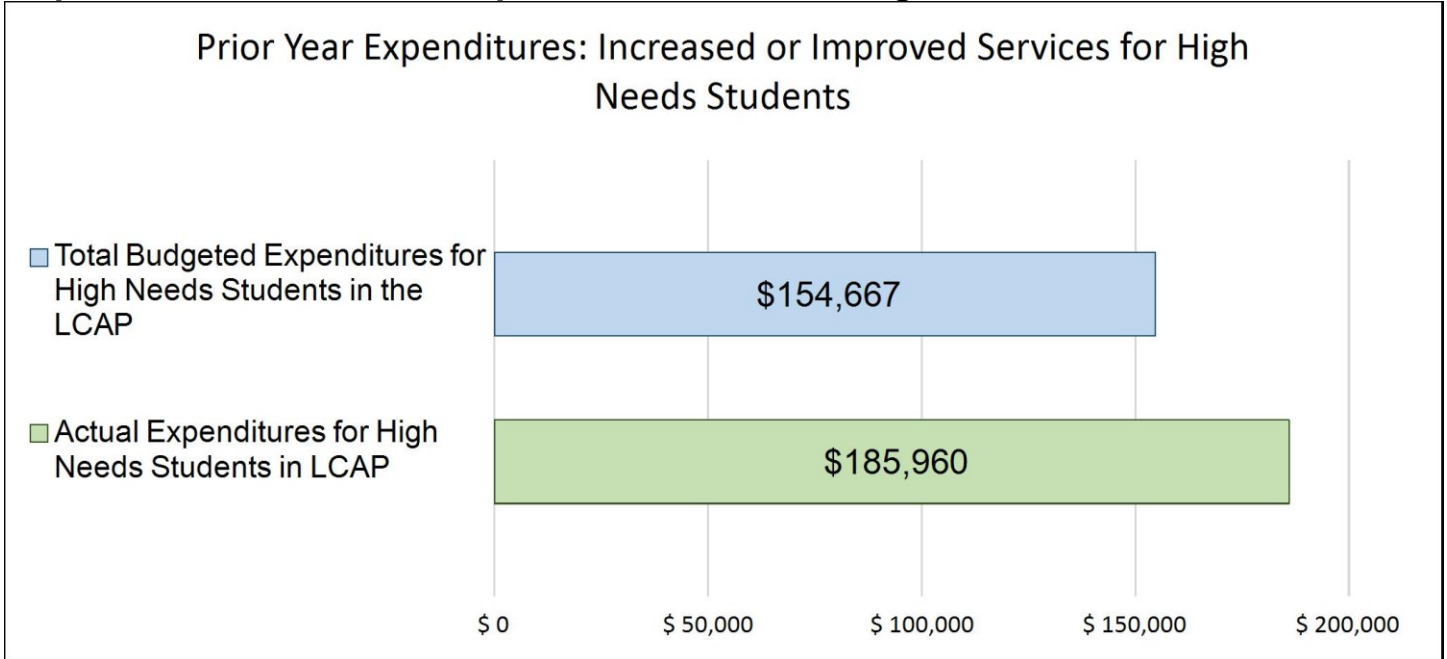
The LCAP identifies all expenditures related to LCFF funds; however, the district's budget also includes additional expenditures for some district-specific costs such as School Board, Administration, and capitol costs which do not directly relate to the goals and actions outlined in the LCAP. The district also maintains general reserve funding held for economic uncertainty. In addition, this reserve includes ongoing facility modernization, and repairs and maintenance of the district-owned well and water tank.

## Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Clay Joint Elementary School District is projecting it will receive \$102,591 based on the enrollment of foster youth, English learner, and low-income students. Clay Joint Elementary School District must describe how it intends to increase or improve services for high needs students in the LCAP. Clay Joint Elementary School District plans to spend \$281,439 towards meeting this requirement, as described in the LCAP.

# Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The actions outlined in goal #1 supported and maintained a culture of high-quality education in an environment designed to increase the academic achievement of all students and subgroups and provide them with opportunities to develop their greatest potential. Clay School still ranks #1 in Fresno County even though our all student group made slight improvement in proficiency in both ELA and Math.

Our ELA Dashboard was Overall Blue at 46.4 points above standard. No subgroups below green.

Our Math Dashboard was Overall Green at 30.6 points above standard. No subgroups in orange or red.

Our English Learner Progress had no performance color as the numbers are not substantial enough.

All 6 actions were carried out as planned in Goal #1. There were no challenges to the actions outlined in goal #1.

1.1 Successes: Fully and appropriately credentialed teachers were hired at all levels with monitoring and supervision by site/district administration support as planned by this action.

Challenges: None. We had an experienced, well-trained staff with one brand new teacher and 4 going through induction or internship programs.

1.2 and 1.3 Successes: We provided an additional credentialed teacher and instructional aides who will continue to provide specialized direct instructional support to students through individualized and small group remediation and acceleration lessons in ELD and DEN, Clay's intervention program Differentiation for Every Need. Our ELD/intervention teacher and aides, including our bilingual aides, ran a successful intervention and ELD program all year which included regularly scheduled diagnostics and regrouping approximately every 8 weeks to maximize individualized instruction based on need. Our DEN program, differentiating for every need, continues to be the foundation of success at Clay School to best meet the individual needs of not just our English learners, foster youth, and low income, but all students on an LEA-wide basis. This year we added intervention in Math in grades Kindergarten through 5th grade.

Challenges: None

1.4 Successes: Clay provided the highest quality of services and facilities to all students as Clay maintained fully and appropriately credentialed Administration and experienced Management and all central office staff and includes all salaries and benefits of Superintendent, Business Office staff, Site Secretaries, Health office nurse/aides, general office materials, supplies, equipment and central office operating costs. We did hire a part-time accountant to help with the esser grant monies and New construction expenditures.

Challenges: None

1.5 Successes: Clay provided all furniture, in fact, we got ALL new furniture in all the classrooms and Learning Center with our remaining building funds, materials, and needed services to certificated and classified in support of student achievement, parent support, and climate and culture.

Challenges: None

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 2: The intervention teacher costs were less than planned. Our hired staff member for intervention needed to take over the 4th grade classroom. We then hired a long term sub to take over intervention, so her daily rate was less than the original teacher.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The actions outlined in goal #1 supported and maintained a culture of high-quality education in an environment designed to increase the academic achievement of all students and subgroups and provide them with opportunities to develop their greatest potential. All 5 actions were carried out as planned in Goal #1 and highly effective. The actions/services performed in this goal have been effective in raising the percentage of proficient students from 64% meets and exceeds to 65% even though the distance from standard in math declined slightly from 31.4 to 30.6. In English Language Arts we increased our percentage of meets and exceeds from 69.83% to 72% but slightly declined in distance from standard by -.4 moving us from 47.4 to a +47. Staff attribute this growth/maintenance to our fidelity to the iReady program, AR, training and delivery in science of reading, and the implementation of Thinking Maps and Write From the Beginning. This data demonstrates the effectiveness of our actions in making progress towards ALL students making annual growth. Staff felt that better fidelity to the programs purchased to close the gaps with the assistance of our instructional aides would yield the gains we were looking to obtain. The Classified instructional aides have remained constant and provided intervention support to positively impact the academic growth of our EL, Foster youth, and low-income students and the challenge of learning a second language while learning grade-level standards for our EL student population. As a result of the implemented actions as planned, the district has improved and maintained moving both ELA and Math. Again, it is important to note when compared to other area and state data these same students are performing better than their neighbors in surrounding school districts. All students will have a broad course of study as measured by teacher schedules. The Clay team will continue to refine instructional practices to further close the existing achievement gap and maintain/improve overall student performance.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

At the end of 2019 Clay had received 4 blues on the California dashboard. This was a first. We were excited about the growth. Things were in place that we believed in and the community gave feedback to keep doing what we were doing. Then COVID hit before we knew what happened. There were no scores in 2020. We started instruction the Tuesday, March 17th, after the lockdown on Friday the 13th. Clay did not miss a beat. In 2021 our meets and exceeds dropped in ELA from 81% to 76%, but our distance from standard numbers went up by +4.9. In Math our meets and exceeds only dropped by 1% as we went from 76% meets and exceeds to 75% and we also grew in distance from standard by +6.2. Our trauma seemed to catch up with us after COVID and hit hard in the 2021-2022 school year. There seemed to be complacency or apathy that set over the world and our campus was no different. In bringing students back to "normal" school our discipline peaked and we had a traumatic event with a weapon on campus. That year resulted in 10 suspensions when our norm was 0-2. That trauma took a toll and our scores in 2022 demonstrated significant loss. In ELA we lost 6% in meets and exceeds and went from 76% to 70% and

had a significant loss in Distance from Standard of -16.6 points. In Math we lost 11% in meets and exceeds and dropped from 75% to 64% with a drastic loss in Distance from Standard at -24 points. We were devastated.

We did not feel, however, that the teaching had changed. We knew that the curriculum and programs had stayed the same. We felt what we were experiencing was more social emotional. So, again, we stayed the course of what we knew worked; curriculum and programs, and focused on building back relationships and providing individual help to all the individuals who were struggling as just incorporating better teaching techniques. Things improved then in 2023 with a 2% gain in meets and exceeds in ELA and a 1% gain in math. We were also now dealing with brand new staff not only learning how to teach, but how to teach to the level of the number one school district in the county.

By the end of the three year cycle, Clay is back to three blues and a green on the California Dashboard. So, after a world wide crisis causing emotional and social crisis in our schools and setting us back, we still know what works and data shows that our baseline program and instruction is solid as Clay has rebounded with solid improvement data cycles that show what we are doing is working. Therefore we will continue to provide intervention staff to support our DEN program, purchase iReady as a progress reporting tool, and bilingual aides to support our EL students.

There were no goals or actions that proved to be ineffective, therefore moving forward Clay School District will maintain all goals and actions as stated.

# Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The actions outlined in goal 2 supported the progress that all students will be provided with a clean, healthy, orderly, physically and emotionally safe environment in which to engage, learn and reach their full potential while parents, family, and community stakeholders will remain fully engaged as partners in the education of their students. All planned actions were implemented. Our transportation was maintained for safe and sufficient transportation throughout the year and even to Los Angeles and the Sierra Nevadas all field trips. Clay School finally completed the long awaited building project started in 2015 and students are now housed in brand new classrooms in grades 4th - 8th grades as well as a brand new Learning Center with new furniture for all these spaces. In addition, we have added gates, fences and a new south entrance so that our school is now more secure and offers a one entry to our school through the office and signing in. Our climate and culture has vastly improved by multiple means. Our Vice Principal facilitated many Student Success Team (SSTs) meetings to meet the specific behavioral and academic needs of referred students by parents or staff. Our school Psychologist had regular leadership meetings with targeted grade levels to address communication styles, conflict resolution and how to be a leader. The staff made an intentional effort to reward more positive behavior with "Pawsitive Picks" - a school wide initiative as well as maintaining the new "Cougar Cave" to campus which is an incentive room earned during one recess a week. Consequently, our suspensions have gone from 10 to 0 last year and back up to 2 this year but the over all behavior on campus is consistently getting better

Successes: All in-district students were provided excellent/safe transportation to and from school. Local and long-distance field trips were provided by our drivers in our buses or contracted out with charter companies. District lunches were collected daily from Selma USD per our contract.

Challenges: None

## Action 2.2 Safe environment and facilities

Successes: We were tremendously successful in moving forward with safety and facilities. Again, we were able to grind down cement areas that caused a tripping hazard. We successfully trimmed back or removed failing trees and replaced them with new trees. All buildings have increased and updated lighting for the exterior which makes it safer for evening activities as well as security when campus is vacant. With the completion of our building project we had left over funds which were to be used at the discretion of the board based on need. All Kindergarten - 8th grade classrooms and the Learning Center were given brand new furniture. All new blinds for the windows in 1st - 3rd as well as the library were purchased which also helped increase privacy for counseling areas. New carpet was ordered for all Kindergarten - third grade as well as the administrative areas. There was a new security screening for all guests and 18 new cameras as well as 2 vape sensors for security.

### Action 2.3

Successes: Our Learning Director was instrumental in the expansion of our PBIS program as it continues to take a deeper dive into the intentionality of praising all students on campus with our PAWSitive Picks handed out daily by all staff to deserving students. We also track the PAWSitive picks to ensure we are getting all the students. This has made a tremendous positive impact on the culture and climate of the school. We have added several new events this year to increase parent participation; Math night for K-3 organized and led by our Learning Director, Mother Son dance, Father Daughter Dance and 3 new field trips for our elementary students where parents are all able to attend. We increased the participation of our students to really be a part of our morning announcements and reading out the PAWSitive picks and bringing back our reward recesses also run and organized by our Learning Director in conjunction with our Associated Student Body. Both have gone over very well. Parent participation is over 94% and close to 100% at several events. Parents are eager to be a part of on-campus events again and their attendance shows that commitment. Even with 2 suspensions that were just isolated, one time events, the over-all behavior on campus has been much better as the students feel more connected with staff.

Attendance continues to be a struggle as so many take their kids out of town. We have our largest numbers of families ever requesting independent study for travel. This has just become a burden to the staff. Rather than spend time after school prepping for the next day or grading papers or extra curricular, they are spending a lot of hours attending to the legal requirements of Independent Study. Chronic absenteeism has maintained. But we are having a hard time getting to the 98% as set back in 2019. Part of our attendance issues besides sickness is behavior. Our Learning Director and Psychologist have worked together to create leadership groups that work through some of the topics that come up on the playground that result in discipline. Because kids feel bullied or not heard, sometimes they don't want to come to school. As we learn of these situations, we try to address them either in classroom settings, with the SEL curriculum or in the leadership sessions with our Psychologist. Having the Psychologist here for an extra day has given her the opportunity to work outside of her Special Education responsibilities and assist with students feeling safe and understood. We have seen a big difference since moving her from one day to two. Our nurse is foundational to the medical needs of our students. By training staff, sitting in 504 meetings to ensure the specific health needs of a few of our students, she gives confidence to parents that their child's needs will indeed be met.

Challenges: in 2.3 Of course we would like to see 100% of our students feeling connected and safe. When asked, the students want taller fences and to lock the door during a fire drill. So, in some cases, it might just be helping the students to better understand what we can and cannot do. Additional challenges are the hours required to maintain the independent study demand.

There are material differences for this goal in action 2.3. All staff received a 5% salary increase for the 2023-2024 school year. General increases to the cost of benefits and retirement contributions were additional factors increasing expenses at Clay. Maintaining competitive salary is necessary to maintaining and attracting quality employees.

The actions outlined in goal 2 supported the progress that all students will be provided with a clean, healthy, orderly, physically and emotionally safe environment in which to engage, learn and reach their full potential while parents, family, and community stakeholders will remain fully engaged as partners in the education of their students.

2.1 Our transportation was effective in providing excellent/safe transportation to and from school. Local and long-distance field trips were provided by our drivers in our buses. District lunches were collected daily from Selma USD per our contract. Three years has maintained with little changes.

2.2 This has been a huge area of change during the last 3 year cycle as we began and completed a long awaited West Wing Project. With this project we were able to provide all new classrooms for 4th - 8th as well as the Learning Center. We were able to upgrade our intercom system, buy new cameras, upgrade the landscaping, increase lighting around campus, add needed cement and grind down compromising cement. We were able to upgrade the Kindergarten through 3rd grade classrooms with all new furniture, new blinds and new carpet as well as upgrade our administrative offices. In three years we added security gates to make sure there was no access on to campus except a one way entry with a screening device in our main office. Our facilities are better than they have ever been. In the area of technology we have purchased promethean boards for all classrooms and purchased new laptops for staff. We also purchase and replaced 15 radios to increase communication. Our new facilities and furniture have given the students and staff a boost of pride in where they come to work and learn every day. This pride leads to a desire to be in the new environment. Our staff no longer has smelly classrooms, torn carpet, mismatched furniture, failing ACs, etc. Instead, they come to brand new classrooms where they had choice in what they purchased for their classrooms. Behavior has improved because students our proud of their new facilities prompting an increased culture of wanting to be respectful to people and things.

2.3 There were some things we took for granted before COVID hit. While we have always been a PBIS school, the effects of COVID made us face the harsh realities on how trauma effects even the most stable kids and families. The impacts of COVID required the increase of 1/5 of our student body which left students feeling uneasy as they struggled to find their place and identity within their age group back in 2021-2022. Surprisingly it had a drastic effect on the over all behavior on campus and we ended the year with 10 suspensions. The most in one year. In addition, we had a traumatic event with a weapon on campus that created a feeling of not being safe. So, for the last three and half years we have had to respond with trauma instruction for adults, revitalizing our PBIS program to be more intentional with catching EVERY student on campus doing something positive. We have added Cougar Cave to promote good behavior on the playground and reward recesses to improve behavior in the classrooms. We have added Student of the Month and Cougar Champions to our recognition. The efforts in increasing positive reinforcement and opportunities to celebrate students is paying off. Even though we had two suspensions, they were isolated, one time events. The over all behavior on campus has been much better as the students feel more connected with staff and motivated to make good choices. In addition, we approved an extra day for Psych services that has proved to be incredibly helpful as they spend their second day working with small leadership groups. These groups work through playground scenarios and learn how to be a good citizen in the midst of conflict. Kids and parents, have expressed in most instances, the benefits of the conversations and students feeling safer.

The actions outlined in Goal 3 supported the progress that all students will have access to rigorous, research-based instructional materials and supplies across the broad subjects and aligned to Common Core State Standards and 21st Century skills to be prepared for high school. All English Learners will receive English Language Development (ELD) aligned to the new ELD standards. We again added training on distance from standards to all students and parents that came to our CAASPP Awards assembly in hopes that we can increase buy in to taking the assessment seriously for increased performance of our already proficient students. We continue to ask the staff where they would like training for the upcoming year and continue to offer training to our new staff. Our arts program continues with a focus on Any Given Child requirements.

3.1 Successes: The district provided Library Media and VAPA Services and instructional materials and supplies to include Math, ELA, NGSS, and VAPA for students that provide students the opportunity to use technology and access to expanded resources through the internet. Challenges none

3.2 Success: Clay staff engaged in professional learning opportunities to develop new instructional strategies and supplemental instructional materials that were effective in meeting the unique needs of our low-income students and all students. These additional learning opportunities for teachers included providing teachers with strategies for supporting language in the classroom, scaffolding writing instruction, and literacy across content areas. We added one additional day to their contract to provide additional hours for Professional Development and collaboration time. Professional Development was provided in vertical articulation in Math, History and ELA integration with writing for 6th - 8th. All teachers had PD in Write from the beginning and Thinking Maps as well as CORWIN PD around Hattie's Visible Learning specifically in Teacher Clarity. All English Learners received designated English Language Development (ELD) with Tier 2-3 support from an ELD pull-out teacher who front-loaded the curriculum. Teachers are trained in how to integrated the ELD supports into the curriculum. Other standards were met via continuing curriculum: Social Studies via Studies Weekly, Science via Amplify, Math via Eureka Math2. Visual and Performing Arts were integrated and Physical Education was taught K-8. Challenges: None

The difference was due to an increased amount in teacher induction with more new teachers in the induction program. In addition, the CORWIN professional development was significantly more than budgeted due to a high demand presenter.

The actions/services (3.1 & 3.2) performed under this goal were effective as exemplified by the development of the English Learners and Low-Income student groups' development of relevant academic language and experiences across broad subjects as measured by lesson plans, administrative evaluations, and student progress/grades and CAASPP scores. 55% of EL students at Clay were Reclassified to Fluent in the spring of 2022 leaving only 4 EL students for 2022-2023. The ELD teacher utilized the ELD components of the Amplify/CKLA curriculum to front-load academic language. Student growth in the demonstration of understanding standards through written expression is based on the effective implementation of writing training in Thinking Maps professional development for the last two years and scheduled to carry on for one more year as well. Based on our local assessment data as of May 2024 our iReady data shows that 74% of ALL students K8 are on or above grade level in Math and 67% of ALL students K-8 are on grade level or above in ELA.

## Plan Summary [2024-25]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Nestled in the rural central valley with views of the snowcapped Sierra Nevada mountains in the winter, pink and white blossomed fruit trees in the spring, and fruit laden trees at the conclusion of the school year, Clay Elementary School is a one-school district located near Kingsburg, California. When the morning bell rings, students and staff members gather from all areas of the school to the center of campus for an opening ceremony. The principal greets all students; announcements are made, birthdays are recognized, and new students are welcomed. After our oldest Cougars lead the Flag Salute, Student Body members read off PAWSITIVE Picks from the previous day celebrating students making good choices, and an inspirational charge is given to do their best, practice their P.A.W.S. and a hearty GOOOO COUGARS, students are dismissed to their classes and the instructional day at Clay School begins. Clay maintains a long-standing tradition of excellence and high expectations from its community.

Since 1880, Clay School has been a shining star in south Fresno County and the greater Kingsburg community. A kindergarten through eighth-grade school, Clay began as a one-room school and is now a beautiful, yet modest, rural country campus with an enrollment of 240. Some of the students at Clay, both past and present, are second, third, and even fourth-generation Clay students. Many traditions of the

school have been maintained over the years, such as the whole school gathering together for the flag salute. Clay students benefit from added upgrades over the years to the school campus such as a beautiful music room, a library/media center, a learning center, a multipurpose building, a kindergarten suite and most recently all new fourth through eighth grade classrooms and Learning Center. In addition we have two new playgrounds, additional fences and gates for safety, 18 new cameras, a new one-way entrance into the school with a new security check in system as well as new lighting and landscaping across the campus.

The Clay staff is one of exceptional loyalty to the school district. Clay School enjoys a staff who are eager to wear the many hats being part of a small district requires. The certificated staff includes the Superintendent/Principal, a Special Education/MTSS Teacher, an Intervention/English Language Development (ELD) Specialist/Vice Principal, a math intervention teacher, 9 classroom teachers, a full-time music teacher/librarian and a full time physical education teacher. The classified staff includes four instructional assistants, one of those being our 2nd bus driver. Clay has a food service assistant, an administrative assistant, a chief business officer/HR Director, a Director of Maintenance/Operations/Transportation/Technology, a full-time grounds/custodian, and one part-time custodian. Clay contracts with the Fresno County Superintendent of School for nursing services, two days of psych services, and All 4 Youth Services. 2023-2024 was the first year with our Expanded Learning After School Program services. and Speech Services are also contracted out. Clay has three members on the Governing Board of Trustees. The Clay community is tight-knit and acts as a large family to ensure the best educational experiences and environment for all Clay students. The community shares common expectations for learners.

Our vision statement sums it up nicely: 'One Community, One Goal: to Exceed Expectations!' We work hard to provide a safe environment that is conducive to learning. There is a special bond that is shared among staff, students, and parents. Students and parents feel that our school represents an ideal, safe, educational setting where a child experiences the security that is necessary for learning to take place. The district is one of choice for many families residing in southern Fresno and northern Tulare Counties. Parents arrive at Clay to complete an inter-district transfer interest form soon after the birth of their child. Consequently, approximately 90% of the students at Clay are enrolled on inter-district transfer permits from neighboring school districts. Our small school atmosphere reflects respect, conservative family values, and a strong sense of community. The Clay School parent population is generous with its time and donates countless hours as classroom volunteers, trip and activity chaperones, as well as most other tasks requested by school personnel.

The Clay student population's ethnic composition remains close to the same from year to year: 0.8% African American, .4% American Indian or Alaska Native, 1.7% Asian, 0.4% Filipino, 0.4% Pacific Islander, 32.4% Hispanic/Latino, 62.7% White, and .8% two or more races, with 0.4% not reported. Up to 10% of the students ride the bus to/from school. Our Clay Cougars continue their outstanding achievement as they attend high school. Over the years, Clay has consistently had at least one student represented among the group of Valedictorians in our feeder high school. In the Class of 2023 it was over 8 Valedictorians from Clay. Local high school teachers have communicated that Clay graduates are "always well prepared."

Clay School is committed to providing a high-quality academic program. Our teachers present a rigorous and challenging curriculum that is aligned with State Adopted Standards. Assessment is used to confirm the alignment of our teaching to our goals and expectations. Our California Assessment of Student Progress and Performance (CAASPP) scores are far above the statewide averages in both Math and English Language Arts. Through our Strategic Action Plan, Clay's staff is making individual growth a priority as we look closely at data to ensure each student is making growth specifically in ELA and Mathematics.

Our daily goal is to champion; "ardently defend the passion and purpose," EACH Clay Cougar and promote each student's intellectual, ethical, emotional, social, and physical growth, and prepare each student to become productive and responsible members of our society. In addition to the community and culture of the school, the many statewide recognition and national distinctions have kept families interested in pursuing education for their children at Clay. Clay was recognized as a California Distinguished School in the years 1997, 2000, 2004, 2008, and 2014, and was honored as a National Blue Ribbon School in 2000-2001 and 2017-2018. In a 2024 Niche survey, Clay Joint Elementary School received the #1 Best Public Elementary School in the Fresno Area out of 230 and maintains the number one school district for ELA CAASPP and Math CAASPP scores. It is the desire of all educational partners to maintain and uphold the principles on which Clay was founded; excellence in education, providing diverse opportunities, and raising strong, moral character that positively contributes to the community,

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Clay was excited to see a return to 3 blues and a green on the California Dashboard. Through the Plan Do Study Act process, we consistently review and modify our plans through improvement science methods to ensure we are making the progress needed to make continuous growth. Our dashboard shows that our hard work is paying off. Clay received an ALL Students Blue for English Language Arts (ELA) with 45.3 Distance from Standard (DFS) points above standard. This was a -0.7 decline DFS from the previous year even though our percentage of meets and exceeds students grew from 69.83% to 72%. In Math we had a green on the dashboard for ALL students at a +28.5 DFS points. We maintained with a slight decline of -1.8 DFS but increased in percentage of meets and exceeds from 64.25% to 65%. In Chronic Absenteeism Clay received an ALL Students Blue with a 1.2% chronically absent which declined by 2.3%. Finally our Suspension Rate for ALL students declined by 3.1% leaving us with a blue on the dashboard.

Our local scores as pulled from our iReady Spring 2023 Scores as compared to our Spring 2024 Annual Growth. All students grew from 64% to 68% proficient in iReady ELA and Low Income grew from 58% to 67% proficient in iReady ELA. All students grew from 70% to 74% proficient in iReady Math Low Income maintained/small decrease from 65% to 63% proficient in iReady Math. EL students group is too small to report growth <10.

Using the Improvement Science method of a Plan - Do - Study - Act cycle every year, we are able to determine the reason for success and missed opportunities in both ELA and Math, ELD and Special Ed that help develop the next steps. Strengths determined for ELA growth were students who wanted to grow and trusted their teachers, targeted instruction, DEN (Differentiated Instruction for Every Need) time which is

targeted/protected differentiated time, Thinking Maps, and Write from the beginning, Accelerated Reading, and continued use of the progress monitoring tool, iReady as both a progress monitoring and intervention tool in addition to the training and implementation of Science of Reading and Data Based questioning in the upper grades. Strengths determined in Math were Eureka aligned curriculum that teaches math specifications, it's complex and digs deep giving students real-life applications. Additional strengths noted were number talks and the progress monitoring and intervention with iReady. In the last three years, we realized fluency in both reading and math are critical as well as fidelity to the iReady program and added math fluency programs of Reflex and Frax. All of these show consistent academic growth when used regularly and a strong correlation in fluency with growth in iReady. After sharing official data with educational partners as well as all staff, it was a unanimous decision, "Keep doing what you're doing," but do it better by reaching deeper and wider and this is how Clay plans to build on existing success. The main findings were how to focus on each individual with specific goals, using the monitoring progress of iReady, AR, DRA, and teacher-made assessments. Monitoring individual student data with conferences will ensure the continued success of each subgroup including our English Learners and low-income as well as each ethnic group.

Feedback from all educational partners; Clay Board of Trustees, certificated staff including special education and EL coordinator, all teachers and administration, and classified staff (no bargaining units), students, SELPA, and PAC (which includes DELAC representatives as we are not required to have an ELAC or DELAC) CSPC (Clay School Parent Club) and other parents/community members has been 100% unanimous to maintain the goals Clay has in place while moving forward with the focus on writing, fluency in reading and math, and maintaining and always improving the climate, culture, and communication. All results were 90% or higher in approval of current practices. In addition, it is encouraged by some of our Clay parents to keep looking for ways to academically challenge our accelerated students.

The entire Clay community continued to express gratitude for the family and community feeling at Clay. ALL educational partners in all surveys gave a 98-100% rating on feeling safe at Clay School and were complimentary of the wonderful Clay staff and all the work that has been done on campus to add additional lighting, new buildings, new gates, new intercom system and a stronger adult presence. Overall, and at over 90% rates or higher in most cases, the Clay community is highly satisfied with the daily operation and academics offered at Clay and want to see the high levels of performance and success maintained. Attendance is a growing concern as we are not making the 98% mark.

All our partners, including our Special Education partners, were happy with the over all direction regarding our goals and actions. Feedback received was to improve specific teacher to parent communication to be more frequent especially around interventions being offered. The request was that parents know when students were targeted around a specific intervention and why. So, that will be a practice our Learning Center will work on with the specific teachers of those targeted students. Our Special Education parents due to IEPs and the request for meetings outside of regular parent teacher conferences, provided opportunities for specific feedback around goals and actions. Our Special education partners voice the expectation to keep their kids motivated to learn and moving forward, not in limbo and at lower levels in the iReady progress monitoring tool. Again, the requests were more day to day practices and not around the larger overarching goals and actions in the LCAP.

An explanation of why the LEA has developed this goal.

At Clay, our ALL group outperforms most state schools and represents one of the highest achieving districts in all of Fresno County and in the top 20 of like school districts in California. Our goal is to increase academic achievement of all students. In order to develop their greatest potential we want to focus on the individual growth of each student knowing that if each improves our overall performance and meets and exceeds will also improve. To focus on growth leading towards proficiency Clay School is focusing on the distance from standard model. So, our growth target is still to move all subgroups further positive distance from the standard each year in both subject areas. Although statistically insignificant and unreported, our English Learner, Foster Youth, and Special Education subgroups are underperforming based on local data. However, when compared to other area and state data these same students are performing better than their neighbors. All students will have a broad course of study as measured by teacher schedules. The Clay team will continue to refine research based instructional practices to further close the existing achievement gap and maintain/improve overall student performance.

An achievement gap exists between the All Student group and the low income subgroup. Local data is collected on English Learners as CJESD does not have enough EL enrollment to be reported to the state. Local data will be used to monitor progress and EL reclassification rates because the subgroup is statistically insignificant. Classroom observations and data collection indicate ongoing professional learning around common core standards would benefit staff and students. Professional learning is valued. Staff model life-long learning. Work to expand the collective staff interest to reflect and discuss obstacles collaboratively.

FIT reports reflect that our buildings are in good condition. Post construction of West Wing, Clay was able to purchase all new furniture, new carpet and new blinds for all classrooms. In addition the office got new carpet, blinds, paint and new cabinets. PBIS interventions have proven successful with the maintenance of 2 or fewer suspensions in previous consecutive years. We've added additional Administrative Titles to several of our current teachers as administrative positions to help facilitate a restorative justice component to add to our PBIS system as well as additional safety in administrative credentials on campus who are trained in crisis situations. We want to maintain our suspension rate at or below 2 or less a year and maintain or improve student attendance to 98%. Educational partner input desires the maintenance of the safe environment while maintaining social and emotional training for our students with a continued contract for Nurse and Psychology services as well as maintain the partnership with All4Youth and FCSS.

- **Student Group(s):** Indicate the student group or groups who will be the primary beneficiary of the action by entering “All,” or by entering a specific student group or groups.
- **Contributing to Increased or Improved Services?:** Type “Yes” if the action **is** included as contributing to meeting the increased or improved services requirement; OR, type “No” if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If “Yes” is entered into the Contributing column, then complete the following columns:
  - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school. An action that is limited in its scope is an action that serves only one or more unduplicated student groups.

  - Building on the example provided above for calculating the Planned Percentage of Improved Services, the LEA in the example implements the action. As part of the annual update process, the LEA reviews implementation and student outcome data and determines that the action was implemented with fidelity and that outcomes for foster youth students improved. The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment. The LEA would divide the estimated actual cost of \$169,500 by the amount of LCFF Funding identified in the Data Entry Table and then convert the quotient to a percentage. ### Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**
  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

**LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.



The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
