




This chart shows the total general purpose revenue Endeavor Charter School expects to receive in the coming year from all sources.



Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Teachers meet once a month for a curriculum review/training, once a month for educational technology training, and once a month PLCs.

Action 7: Administer Academic Assessments: The school will deliver academic assessments to all students, both the CAASPP and the school's internal assessment and evaluations.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. 97% of our 3rd, 8th and grade11 students combined participated in ELA SBAC testing. 98% of our 3rd-8th and grade 11 students combined participated in Math SBAC testing. NWEA test administered to all K-11th grade students for Spring 2023 and Fall 2023.

Action 8: Ongoing Staff Development: Provide ongoing staff development & articulation to support Math, English Language Arts and Science state standards implementation and monitoring.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Teachers meet once a month for a curriculum review/training, once a month for educational technology training, and once a month PLCs.

Action 9: Administration to Assess Student Needs: Administrative meetings and other administrative training devoted to assessing & refining our staff professional development planning and process and to identify critical areas of student needs.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Administrators have meetings twice a month, and attend professional conferences and trainings to assess & refine our staff professional development planning and process and to identify critical areas of student needs.

Action 10: College/Career Readiness Guidance: Provide 7-12th grade students with grade-appropriate College and Career Readiness guidance to increase student preparedness for college and post high school success. *College and Career Readiness means as measured and reported on the CA Dashboard percentage of graduating students.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Guidance Counselor holds weekly workshops to engage students and parents in college and career readiness. Guidance Counselor and Advising Teachers provide guidance on High School Enrichment Program, A-G requirements, diploma tracking, and CTE Pathways. Advising Teachers and Guidance Counselor participate in ongoing college and career PD. Guidance Counselor and teachers take students on field trips to UCs, State Schools, and College and Career Fairs.

Action 11: Developing Additional CTE Pathway: Research and develop a new CTE pathway.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. CTE Education pathway is in year 2. The Business Pathway is currently being developed and will be implemented in Fall 2024.

Action 1: Janitorial Service: Provide regular, ongoing janitorial service for the buildings.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Janitorial services for the building are provided daily.

Action 2: Building Grounds Maintenance: Provide regular, ongoing landscape maintenance as needed.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Endeavor provides regular, ongoing landscape maintenance as needed.

Action 3: Addressing Safety Issues: Address all critical safety issues in a timely manner.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Endeavor address all critical safety issues in a timely manner.

Action 4: Building Modifications: Plan & perform building modifications to better serve our school's mission as needed.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Endeavor plans & performs building modifications to better serve our school's mission as needed. This year some of the improovements included: Installation of window privacy film, reception remodeling, and installation of artificial turf.

Action 5: Community-Based Family Resources: Maintain and publish a list of community-based mental health services and support as a resource for students and families.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Endeavor maintains and publishes a list of community-based mental health services and support as a resource for students and families.

Goal 3:

Action 1: Parent Workshops: Provide parent training and workshops to support student achievement and their roll as an important leader in the life of their student. (This may include both specific workshops but also during the PLP meeting)

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Teachers meet with parents and students a minimum of once every 20 school days. Guidance councelor holds weekly college and career guidance for parents and students. Endeaor hosts college application and FAFSA workshops.

Action 2: Communication: Provide methods of communication between home and school via Parent Square, social media, school websites, newsletters, advising and other meetings

Implementation status: Currently met, ongoing, sustainable & consistently monitored for compliance. Endeavor sends out monthly newsletters. Advising teachers woork closely with parents and students in their monthly PLP meetings. School posts news and events on social media and also sends these communications through Parent Square. The school website has all required information as well as other helpful links and information for students and thier families.

Action 3: Educational Partner Feedback: Provide opportunities for involvement, input, and feedback from all Educational Partners on aspects of our school program, safety, and culture to enhance student success.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Monthly PLP meetings, Work with Parsec of data analysis and regular board meetings and LCAP meetings all provide regular partner feedack.

Action 4: Educational Partner Engagement: Develop, as needed, Advisory Groups and opportunities for Educational Partner engagement. Existing and future Advisory Groups could focus on issues such as: Technology development, Professional development for staff, School Safety, Curriculum, LCAP goals, Community impact and increased diversity.

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Advisory groups have been formed to review curriculum needs and adoptions, best practices for teaching and advising, school safety committees. LCAP focus groups met throughout the spring to assess goals and actions.

Action 5: Community Engagement Opportunities for Students: Provide opportunities for our students to explore and engage with the greater community around them through educational and service-related field experiences. (For example: Reagan Library, Catalina CIMI science trip, science & art exploration trips, visits and interviews with businesses, university tours and community service)

Implementation Status: Currently met, ongoing, sustainable & consistently monitored for compliance. Regan Library and Catalina CIMI are well established annual field trips for our students. University/college tours have also become a recent regular annual field trip. Community service opportunities now take place on a monthly basis through the Community Food Bank and Alive Inside. Business interviews take place as part of the high school leadership class.

Overall Analysis:

SBAC results showed marked growth over the course of the three year cycle, despite the loss of learning during COVID years. Early growth was hard to track due to Endeavor's recent establishment, but over the last two years there was considerable growth. We continue to diligently support our struggling students in the area of improved technology, onsite classroom instruction, tutoring and close monitoring of academic progress between the Advising Teacher, parent/guardian and student.

In the 2024-2025 LCAP we will be changing action 1.4 "Provide training for teachers to increase their technical and instructional effectiveness with educational technology and virtual learning settings in order to facilitate pupil success," and 1.7 "Administrative meetings and other administrative training devoted to assessing & refining our staff professional development planning and process and to identify critical areas of student needs," to be included in action 1.6 "Provide ongoing staff development & articulation to support Math, English Language Arts and Science state standards implementation

and monitoring," to create one action that is inclusive of all staff training and professional development. Action 1.9 "Research and develop a new CTE pathway," is being removed because it was accomplished.

General Information

Endeavor Charter School opened in July 2020 and operates a TK-12 program that has come to be known as "personalized learning". Personalized Learning has been acknowledged and commended with a State Senate resolution (SR-36). Personalized learning is a unique blended classroom and non-classroom based public educational model that is tailored to the needs and interests of each individual student. As a school we do not dictate to students and their parents how to engage the learning material. Rather, we set before them the educational goals and work cooperatively with them in creating customized learning plans that best reach those goals. We believe that their desires, strengths and needs are crucial to how the school works with them as individuals. This methodology, both curricular and instructional, is built around each student's needs, abilities and interests. All students meet with their teacher and parents together to create their own personalized learning plan (PLP) at least monthly and to evaluate effectiveness and needed supplementation or change. The PLP brings student, parent and teacher together in a formalized relationship for the sole purpose of planning, implementing, assessing and adjusting the student's educational program. The PLP process includes frequent, regularly scheduled meetings of the parent, student and teacher, assessment of the student's academic strengths and weaknesses, development of a curricular and instructional plan tailored to the student, ongoing monitoring and collection of student work and adjustment to meet the student's needs. The PLP process is a thorough, formal but personal system that meets each student's academic needs in a very precise, individual, and responsive way.

Enrollment Data for 2023-24:

Our student enrollment this year is 335 students (112 in 9-12 and 223 in TK-8) with a waiting list for the 2024-25 SY. Our students reside in the Central Valley of Fresno County.

The ethnic make-up of our students: 2.99% Black or African American, 0.3% American Indian, 2.69% Asian, 1.19% Filipino, 41.79% Hispanic, 0.6% Pacific Islander,

2.69% Declined to State, and 42.69% White.

Of this population, 41.79% of total enrollment is Socioeconomically Disadvantaged, 12.54% are Students with Disabilities, 0.3% are Homeless or

Foster Youth, and 2.39% are English Learners

Reflections: Annual Performance

As a fourth year CA Public Charter School, Endeavor Charter is proud of what we have accomplished as a TK-12 charter school in Fresno County. Successes included, but are not limited to: Providing high-quality educational options to students and their parent/guardian (recent parent surveys indicated that over E:99% of our parents would recommend our school to others), providing effective support to all students (per student survey E:96% of student feel the school provides support to them and their parents), teachers (with parent/guardian collaboration) effectively providing educational plans for all students through our personalized learning plan (PLP) model.

In addition, students in grades TK-11 participated in Benchmark NWEA MAP Testing at the beginning, midyear (as needed), and end of the school year to assess areas of growth, create student academic goals, and provide appropriate student supports. Because end-of-year NWEA testing is still underway, we reported NWEA results comparing the same cohort of students in Fall 2022 with Fall 2023 to assess learning.

E: The results showed a slight dip in Reading and Math scores remained about the same. The 2022-2023 school year SBAC testing participation rate for grades 3-8th and 11th grade students was E: 97%. In addition, our CST Science test scores in all grades tested (5th, 8th and High School) were strong and our proficiency rates were higher than the state proficiency rates. We are proud of our Advising Teachers and Support Staff who provide all students, including those with diverse learning needs, and their parent/guardian, excellent support and assistance on a frequent and regular basis. All students were provided with appropriate curriculum, a variety of additional learning materials, and Chromebooks. Endeavor Charter School continuously provides student engagement through extracurricular opportunities, such as sports, academic competitions, field trips, onsite classes and activities. Overwhelmingly, responses from our school climate surveys given to students and parents were positive. Most parents and students felt the school supported their needs, including educational-related technology needs and access to educational materials. Most parents also rated our school "above average" and "excellent" in how well we communicated to them about school events and procedures.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. The LCAP template, like each LEA's final adopted LCAP, is a document, not a process.
