Robert began teaching for the Court Schools at the County's Boot Camp school, which was later named the Violet Heintz Education Academy. When he began, the facility had been closed for 5 years, it was overgrown with weeds, and there was no running water. At that time, it was a Day Reporting Center and the students were bussed in everyday from Fresno to attend school and to work. There were two teachers that shared three classes, and the classes ran as they do now from 8:00 AM-5:35 PM. Robert says he remembers it as dirty and dusty; and the power and phone service were sporadic depending on what the maintenance workers were working on a given day. The facility today is much improved and provides an excellent learning environment for students. Through it all, Robert has maintained his focus on providing quality educational programming, and is truly a catalyst for student success.
