Expulsion Appeal – Central Unified School District

The Board moved into deliberations at 3:35 p.m. and reconvened into closed session at 3:41 p.m. Member Clyde moved to affirm the findings, seconded by Member Cederquist. Motion carried by a 5-0 roll call vote.

Order of the Board:

The Fresno County Board of Education remands the decision of the Central Unified School District Governing Board to expel the student for a new hearing and to consider the evidence proffered by the Appellant. The Fresno County Board also recommends that an interpreter be provided.

Member Clyde moved to adopt the above order, seconded by Member Cederquist. Motion carried by a 5-0 vote.

Expulsion Appeal – Fresno Unified School District

The hearing was called to order at 3:58 p.m.

Board members sought input from those present.

The Board moved into deliberations at 4:20 p.m. and reconvened into closed session at 4:24 p.m. Member Clyde moved to affirm the findings, seconded by Member Eubanks. Motion carried by a 5-0 roll call vote.

The Fresno County Board of Education affirmed the decision of the Fresno Unified School District Governing Board to expel the student.

Member Cederquist moved to affirm the District's decision to expel the student; seconded by Member Clyde. Motion carried by a 5-0 roll call vote.
