Those present at the hearing included: Bryan Martin, Legal Counsel for Fresno Unified School District, and Ambra Dorsey, Fresno Unified School District representative; members of the Fresno County Board of Education; Larry Powell, County Superintendent of Schools; Jim Yovino, Deputy Superintendent; Jason Parkin, Legal Counsel; and Gloria Ferrer, Administrative Assistant to the Fresno County Board of Education.

Board members sought input from those present.

The Board moved into deliberations at 3:22 p.m. to discuss the following Finding of Facts:

- 1. Did the district's governing board proceed without or in excess of its jurisdiction in expelling the pupil?
- 2. Did the pupil receive a fair hearing before the district governing board?
- 3. Was there a prejudicial abuse of discretion by the district governing board?
- 4. Is there now relevant evidence which, in the exercise of reasonable diligence, could not have been produced or which was improperly excluded at the hearing before the governing board?

The Board reconvened at 3:28 pm.

Vice President Clyde moved to adopt the Findings of Fact of the Fresno Unified School District, seconded by Member Eubanks; motion carried unanimously.

Order of the Board: Vice President Clyde moved to affirm the District's decision to expel the student, seconded by Member Eubanks; motion carried unanimously.
