Her vast experience in classroom structure, organization and behavior management continues to significantly accelerate student learning. Christy is a team player and leads with her heart. She is a great resource for other teachers struggling with organization and curriculum adaptation. Christy readily volunteers to assist with administering standardized testing for classrooms, serves on a myriad of projects for special education and is a California Alternate Proficiency Assessment (CAPA) Trainer of Trainers. Christy is often called upon to assist other special education teachers with questions and training in administering the CAPA on a yearly basis for second grade through eleventh grade students with moderate to severe disabilities.

Christy actively integrates academics and the arts into her classroom. She completes class-wide art projects with her students and enters these projects in The Big Fresno Fair. She works tirelessly on developing and adapting curriculum, including creating curriculum to work on fine motor skills when no equivalent commercial curriculum is available. Christy has brought small domestic animals into her classroom and ties their care and feeding into student IEP goals and objectives. She has developed on-campus vocational training for some of her eighth grade students and works closely with general education staff at her school site. Christy includes her students in school-wide activities and is a master at collaborating. She engages and includes the families, general education staff as well as her designated instructional specialist team of School Psychologists, Speech and Language Pathologists and Occupational Therapists into all aspects of her students' educational plans.
