Those present at the hearing included: student's mother, Shelia Sims, Fresno Unified School District Attorney, Bryan Martin, and Fresno Unified School District representatives, Ambra Dorsey and Rob Reyes; Jim Yovino, Superintendent of Fresno County Schools; Linda Bacon, General Legal Counsel, Fresno County Office of Education; and Gloria Ferrer, Administrative Assistant to the Fresno County Board of Education.

Board members sought input from those present.

The Board moved into closed session for deliberations at 2:58 p.m.

The Board reconvened into open session at 3:13 p.m.

Findings of Fact:

- 1. The District governing board did not proceed without or in excess of its jurisdiction in expelling the Appellant.

- 4. There is not now relevant and material evidence which, in the exercise of reasonable diligence, could not have been produced, or which was improperly excluded, at the hearing before the District governing board/administrative hearing panel.

The Fresno County Board of Education affirms the decision of the District Governing Board to Expel the Appellant.
