RESOLUTION NO. 2024 - 45

WHEREAS, pursuant to Education Code, section 5326, no Fresno County Board of Education election was held and conducted for Trustee Area Nos. 2, 3, and 5 on the last board member election date due to only one person being nominated for those board member terms expiring on the second Friday in December, and no petitions signed by 10 percent of the voters or 50 voters, whichever is the smaller number, in the applicable trustee areas were filed with the Fresno County Elections Department, at least 83 days prior to the last governing board member election date requiring an election; and

WHEREAS, Education Code, section 5328, requires that those persons nominated to run in the election in such circumstances shall be seated at the organizational meeting of the County Board as if elected at a board member election.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education hereby submits that the following are seated by operation of law because the candidate ran unopposed for the office:
