RESOLUTION NO. 2025 - 08

WHEREAS, pursuant to Education Code ("EC") sections 47605, 47607, and 47607.2, the Fresno County Board of Education ("County Board"), on January 23, 2025, received a renewal charter petition ("Renewal Petition") seeking a five year term beginning July 1, 2025 and ending June 30, 2030, for the Career Technical Education Charter ("CTEC"); and

WHEREAS, CTEC is currently authorized pursuant to a charter that had previously been granted by the County Board for the term of July 1, 2017 through June 30, 2022 and which was subsequently extended by law, pursuant to EC section 47607.4, through June 30, 2025; and

WHEREAS, a committee ("Charter Committee") reviewed the Renewal Petition pursuant to the criteria established in EC sections 47605, 47607, 47607.2, and other applicable statutes and regulations; and

WHEREAS, a public hearing on the Renewal Petition was conducted on February 18, 2025 at which time the County Board received and considered the level of support for the Renewal Petition; and

WHEREAS, the Charter Committee reviewed the Renewal Petition and submitted for the County Board's consideration a Committee Report regarding the Renewal Petition dated March 5, 2025 ("Committee Report"), which is attached hereto, in which the Charter Committee makes certain findings and recommends that the County Board approve the Renewal Petition.

WHEREAS, the County Board has reviewed the Renewal Petition, including the supporting documentation and information; considered applicable law and regulations; and reviewed and considered the Committee Report, including analysis and recommendation.

WHEREAS, based on the criteria set forth in EC sections 47605, 47607, 47607.2, and other applicable law and regulations, the County Board has done the following: (1) Considered the schoolwide performance and performance of all subgroups of pupils served by CTEC on the state indicators included in the evaluation rubrics adopted pursuant to EC section 52064.5 and the performance of CTEC on the local indicators included in the evaluation rubrics adopted pursuant to EC section 52064.5; (2) Provided greater weight to performance on measurements of academic performance in determining whether to grant the CTEC charter renewal; (3) Considered clear and convincing evidence showing that CTEC achieved measurable increases in academic achievement, as defined by at least one year's progress for each year in school, or strong postsecondary outcomes, as defined by college enrollment, persistence, and completion rates equal to similar peers; (4) Reviewed all required data pursuant to EC 47607 and 47607.2; and (5) evaluated whether CTEC has complied with the criteria set forth in EC 47605.

NOW, THEREFORE, BE IT RESOLVED by the Fresno County Board of Education as follows:

1. The County Board finds the above-listed recitals to be true and correct and incorporates them herein by this reference.
2. The County Board hereby adopts the Committee Report (See attached Committee Report), including all findings therein, which is incorporated herein in its entirety by this reference.
3. The County Board, having reviewed and considered the Renewal Petition, supporting documentation and applicable data, applicable EC sections, other applicable laws and regulations, the applicable criteria, and the Committee Report, hereby approves the Renewal Petition for a term of five years (July 1, 2025 through June 30, 2030).
